Authorization to amend the Lease Agreement with Edmon Chaney for approximately 2,808 Sft of residential space for the Premise known as Masterson Station Park (House #1) which is located at 3401 Shamrock Lane in Lexington. The amendment allows for continued occupancy at the same terms and conditions and expires on December 31, 2015. The revenue from the lease agreement is \$1,887.30 over six months. (L0864-15)(Reed)
