BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 3 - That an amount, not to exceed the sum of \$708.00 in FY 2024, be and hereby is approved for payment to Procure Solutions, from account #1101-606401-75101, pursuant to the terms of the Contract, and subject to the Budgeting of sufficient funds in future fiscal years.

Section 4 - That this Resolution shall become effective on the date of its passage.
