## **URBAN COUNTY GOVERNMENT:**

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$\_52,242.00 \_\_from\_ the General Services District Fund \_from\_ various accounts.

) \$\_123,671.00 \_ to\_ the Full Urban Services District Fund \_from\_ various accounts.

) \$\_39,476.00\_ \_from\_ the Sanitary Sewer Revenue and Operating Fund \_to\_ various accounts.

) \$\_6,582.00 \_ from\_ the Landfill Fund \_to\_ various accounts.

) \$\_25,371.00 \_ from the Enhanced 911 Fund to various accounts.

) Re-appropriations within the General Services District Fund, Donation Fund, Refunding Go Bond 2015A Fund, 2017 Bond Projects Fund and the various Grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.
