Section 4 - That an amount, not to exceed the sum of \$1,461,588.00, be and hereby is approved for payment to AVOL Kentucky, Inc., from account #3120-900212-71101 (\$1,359,277.00) and account # 3120-900212-82301 (\$102,311.00), pursuant to the terms of the Subrecipient Agreement.

Section 5 - That this Resolution shall become effective on the date of its passage.
