A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute a multi-year Agreement with Vision Internet Providers, Inc., as the sole-source provider, for an upgrade to the Lexington-Fayette Urban County Government Intranet website, at a cost not to exceed \$29,050 in Fiscal Year 2015, with additional funding for required subscription services subject to appropriation of sufficient funds in future Fiscal Years. [Div. of Computer Services, Nugent] Authorization to enter into an agreement with Vision Internet to upgrade our version of the Vision content management system (CMS) and renew the support contract initially established under resolution 554-2004. The current version of our intranet content management system is out of support. The cost will be \$29,050 to upgrade our version and renew the support contract. The annual impact of the contract will initially be \$7,800 and will increase by 5% annually. Funds are budgeted for the upgrade. (L0729-15)(Nugent/Valicenti)
