A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute a Lease Agreement with the Lexington & Fayette County Parking Authority for space located at 162 East Main St. [Div. of Facilities and Fleet Management, Baradaran]

Authorization to enter into a lease agreement between the LFUCG and Lexington & Fayette County Parking Authority for space located at 162 East Main Street within the Annex Building. The area is located on the second floor of the facility and consists of approximately 703 Sft of space. The initial term of the agreement will be for a period of twelve (12) months, beginning July 1, 2015 and ending on June 30, 2016 with an option of automatic annual renewal for two (2) additional one year terms. LFUCG will receive Fair Market Value for use of the space with an annual rent of \$9,110.88 during the agreement. (L0685-15)(Baradaran/Reed)
