Section 1 - That the bid of REM Company, Inc., in the amount of \$216,950.00 in FY2020, for the purchase, installation, and maintenance of six Commercial Washers and five Commercial Dryers

for the Division of Community Corrections, be and hereby is accepted and approved as to the specifications and amounts set forth in the terms of the bid and agreement, which are attached hereto and incorporated herein by reference, and the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute a multi-year maintenance agreement with REM Company, Inc., related to the bid.
