This action is being requested to give better access and resources to Computer Services. It will also provide back up to the various computer based programs and services. WHEREAS, Section 6.12 of the Charter of the Lexington-Fayette Urban County Government provides that the Council shall have the power to "consolidate, divide, and otherwise restructure the organization of all departments, offices and divisions covered by Article 6 of the Charter"; and WHEREAS, it has been determined that effective and efficient operation of government will occur by transferring certain positions from the Division of Community Corrections to the Division of Computer Services.
