Section 2 - That an amount, estimated not to exceed the sum of \$14,400.00 in FY 2024, be and hereby is approved for payment to GOGov, Inc. from account # 1101-121001-75103, pursuant to the terms of the Order Form, with annual increases not to exceed seven percent (7%) and subject to the appropriation of

sufficient funds in future fiscal years.
