WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

Government for Committee of the Whole appropriations for parking repairs, compensation study, and IT infrastructure

as approved at Work Session on October 26, 2021:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended for Committee of the Whole appropriations for parking repairs, compensation study, and IT infrastructure as approved at Work Session on October 26, 2021 and that to effect such Amendments the following appropriations be and

hereby are authorized and directed:

) \$678,500 from the Unappropriated Fund Balance in the General Services District-General Fund to various accounts.

) Re-appropriations within the General Fund Capital Projects Fund which does not result in changes to the Unappropriated Fund Balance of this fund.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0021", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.

WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government for Committee of the Whole appropriations for parking repairs, compensation study, and IT infrastructure as approved at Work Session on October 26, 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended for Committee of the Whole appropriations for parking repairs, compensation study, and IT infrastructure as approved at Work Session on October 26, 2021 and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$678,500 from the Unappropriated Fund Balance in the General Services District-General Fund to various accounts.

) Re-appropriations within the General Fund Capital Projects Fund which does not result in changes to the Unappropriated Fund Balance of this fund.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0021", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
