BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

(“CAC”) in order to allocate \$6,921,202.20 of federal Emergency Rental Assistance Grant funds awarded under Section 501(a) of Division N of the Consolidated Appropriations Act, 2021 (ERA 1) to CAC for the continued operation of the Housing Stabilization Program, and authorizing the Mayor to execute any other needed Agreements or amendments with CAC related to the use of these funds.
