Authorization to enter into an extended warranty Agreement with Romaine Companies for the body scanner located at the Fayette County Detention Center. The Division purchased a dual view body scanner from Romaine Companies in 2018 (R712-2018). Romaine is the sole source provider for the body scanner, the Division wishes to purchase a four (4) year extended warranty to be paid annually. The extended warranty includes parts, labor, travel, software updates, and annual radiation inspections. Funds are Budgeted for FY22 and will be requested in the future years.
