A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute a Second Amendment to Agreement with Corizon, Inc., for provision of health services at the Detention Center, to add an ACA Coordinator at an additional cost not to exceed \$49,812 for FY 2016, and to increase the contract by the mandated CPI increase at an additional cost not to exceed \$59,556.46 for FY 2016, for a total cost not to exceed \$3,260,504.16 for FY 2016. Authorization to approve Amendment #2 to the contract between the LFUCG and Corizon, Inc. This amendment will provide funding for a full time ACA Coordinator to assist with filing of medical claims, and to increase the contract by the mandated CPI increase. The additional cost is \$49,812 for the ACA coordinator and \$59,556.46 for the CPI increase for a total increase of \$109,368.46. The FY16 base contract price will be \$271,708.68 per month, an increase of \$9,114.04 per month. The request is fully funded in the proposed FY16 budget and execution will be contingent upon funding. (L0596-15)(Ballard/Bastin)
