Section 3 - That the incumbent, Christopher Edwards, be and hereby is reclassified from Video Specialist, Grade 518E, at \$2,604.96 biweekly to Video Production Supervisor, Grade 522E, at \$2,969.68 biweekly.

Section 4 - That this Ordinance shall become effective on passage of Council.
