A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute an Agreement with the U.S. Dept. of Justice to accept a Grant of \$6,363 in Federal funds under the Bureau of Justice Assistance FY 2021 State Criminal Alien Assistance Program (SCAAP), for reimbursement of costs related to the incarceration of undocumented criminal aliens, the acceptance of which does not obligate the Urban County Government to the expenditure of funds, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget. Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be

and hereby is authorized and directed to execute an agreement with the U.S. Department of Justice,

attached hereto and incorporated here by reference, to accept a Grant of \$6,363.00 in Federal funds

under the Bureau of Justice Assistance FY 2021 State Criminal Alien Assistance Program (SCAAP),

for reimbursement of costs related to the incarceration of undocumented criminal aliens, the

acceptance of which does not obligate Urban County Government to the expenditure of funds.

Section 2 - That subject to the provisions of Section 7-48 of the Lexington-Fayette Urban

County Government Code of Ordinances, the Mayor is hereby authorized, in her discretion as Chief

Executive Officer of the Urban County Government, to transfer the unencumbered balance of any

operating or capital account appropriation to another operating or capital account appropriation within

the Grant budget established herein.

Section 3 - That this Resolution shall become effective on the date of its passage.
