A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute Supplemental Agreement No. 1 with the Ky. Transportation Cabinet for acceptance of \$32,000 in Federal funds, under the Ky. Transportation Cabinet Surface Transportation Program (SLX), for the design phase of the Wilson Downing Intersection Improvements Project, the acceptance of which obligates the Urban County Government to the expenditure of \$8,000 as a local match, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget for these Grants. Authorization to execute Supplemental No. 1 Agreement and accept \$32,000 in Federal funds under the Kentucky Transportation Cabinet Surface Transportation Program (SLX) for the design phase of the Wilson Downing InterSection Improvements Project. County Government Code of Ordinances, the Mayor is hereby authorized, in her discretion as Chief

Executive Officer of the Urban County Government, to transfer the unencumbered balance of any

operating or capital account appropriation to another operating or capital account appropriation within

the Grant Budget previously established for this Grant.
