A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to accept a Grant from the Ky. Justice and Public Safety Cabinet, which Grant funds are in the amount of \$95,445 Commonwealth of Ky. funds, under the Victim Assistance Formula Grant, are for the operation of the Underserved Minority Victims Advocacy Program, for the Dept. of Social Services, the acceptance of which obligates the Urban County Government for the expenditure of \$32,773 as a local match, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget. [Dept. of Social Services, Ford]

Authorization to accept an award of Federal funds from the Kentucky Justice and Public Safety Cabinet in the amount of \$95,445 under the Victim Assistance Formula Grant funded by the Victims of Crime Act for the operation of the Underserved Minority Victims Advocacy Program in the Department of Social Services. Match in the amount of \$32,773 is required. Budget Amendments are in process. (L0030-18) (Ford)

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY
GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to accept a Grant from the Kentucky Justice and Public Safety Cabinet, which Grant funds are in the amount of \$95,445 Commonwealth of Kentucky funds, under the Victim Assistance Formula Grant, are for the operation of the Underserved Minority Victims Advocacy Program, for the Department of Social Services, the acceptance of which obligates the Lexington-Fayette Urban County Government for the expenditure of \$32,773 as a local match.

Section 2 - That subject to the provisions of Ordinance No. 22-79, the Mayor is hereby authorized, in his discretion as Chief Executive Officer of the Urban County Government, to transfer the unencumbered balance of any operating or capital account appropriation to another operating or capital account appropriation within the Grant Budget established herein.

Section 3 - That this Resolution shall become effective on the date of its passage.
