A Resolution authorizing and directing the Mayor, on behalf of the Lexington-Fayette Urban County Government, to execute Change Order No. One (1) to the Third Amendment to the Purchase Agreement with Airbus DS Communications, f/k/a Cassidian Communications, Inc., for the purchase of a heavier tower for the Public Safety Operations Center, increasing the agreement price by the sum of \$17,688 from \$1,542,083 to \$1,599,771. [Div. of Emergency Management/911, Stack] Authorization to approve a Change Order and corresponding Airbus Change Notice to the Purchase Agreement (ref. Resolution 507-2015) in order to have Airbus DS Communications (Airbus) supply a heavier tower at the Public Safety Operations Center that is capable of holding additional antennas proposed by Emergency Management. The cost of the change order is \$17,688. The new contract amount is \$1,559,771.00. Funds are budgeted using CSEPP funds. (L1384-15)(Stack/Bastin)
