A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute and submit a Grant Application to the Ky. Div. of Water, which seeks \$150,000 in Commonwealth of Ky. funds under the 2024 Section 319(h) Grant Program, for the West Hickman Watershed Project for the Div. of Environmental Services, to provide any additional information requested in connection with this Grant Application, and to accept this Grant, if awarded, the acceptance of which obligates the Urban County Government to the expenditure of \$100,000 as a local match, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget. Authorization to submit an application to the Kentucky Division of Water, and accept funding, if awarded, under the 2024 §319(h) Grant Program requesting funding in the amount of \$150,000 for a West Hickman Watershed Project on Pimlico Parkway for the Division of Environmental Services. Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be

and hereby is authorized and directed to execute and submit a Grant Application, which is attached

hereto and incorporated herein by reference, to the Kentucky Division of Water, which seeks

\$150,000.00 in Commonwealth of Kentucky funds under the 2024 Section 319(H) Grant Program, for

the West Hickman Watershed Project for the Division of Environmental Services, and to provide any

additional information requested in connection with this Grant Application, and to accept this Grant, if

awarded, the acceptance of which obligates the Urban County Government to the expenditure of

\$100,000.00 as a local match.

Section 2 - That subject to the provisions of Section 7-48 of the Lexington-Fayette Urban

County Government Code of Ordinances, the Mayor is hereby authorized, in her discretion as Chief

Executive Officer of the Urban County Government, to transfer the unencumbered balance of any

operating or capital account appropriation to another operating or capital account appropriation within

the Grant budget previously established for this Grant.

Section 3 -- That this Resolution shall become effective on the date of its passage.
