**URBAN COUNTY GOVERNMENT:** 

Section 1 - That Section 2 of Resolution No. 332-2014 be and hereby is amended to read as

follows:

That an amount, not to exceed the sum of \$104,775.00 be and hereby is approved for

payment to EHI Consultants, from account #1101-160701-0001-71299 (\$65,000.00) and

account #3300-160701-0001-71299 (\$39,775.00), pursuant to the terms of the

agreement.

Section 2 - That the remainder of Resolution No. 332-2014 is unchanged

Section 3 - That this Resolution shall become effective on the date of its passage.
