A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to accept a Grant from the Dept. of Juvenile Justice, which Grant funds are in the amount of \$100,000 in Commonwealth of Ky. funds, for the operation of the Day Treatment Program within the Div. of Youth Services for 2022, the acceptance of which obligates the Urban County Government to the expenditure of \$394,698 as a local match, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget for this Grant. Authorization to accept award offered from the Kentucky Department of Juvenile Justice in the amount of \$100,000 for provision of Day Treatment Services in the Division of Youth Services for FY 2022. capital account appropriation within the Grant budget previously established for this Grant.
