WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

various accounts.

) \$1,905,782.66 from the Unappropriated Fund Balance in the Municipal Aid Program Fund to various accounts.

) \$443,567.32 from the Unappropriated Fund Balance in the County Aid Program Fund to various accounts.

) \$56,567.46 from the Unappropriated Fund Balance in the Mineral Severance Fund to various accounts.

) \$29,200.00 from the Unappropriated Fund Balance in the Coal Severance Fund to various accounts.
