BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 2 - That an amount, estimated not to exceed the sum of \$62,260.00, be and hereby is approved for payment to Straeffer Pump & Supply, Inc., from account # 4003-303408-3468-92811, pursuant to the terms of the purchase requisition.
