A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute a multiyear Agreement to procure software and related services under the same terms and conditions as MA-758-1800000017, a Contract between SHI, Inc. and the Commonwealth of Ky., including proposal #24914828, at a cost not to exceed \$1,306,579.09 in FY 2025, with future renewals subject to the appropriation of sufficient funds; and authorizing the Chief Information Officer, or her designee, on behalf of the Urban County Government, to execute any necessary documents related to the procurement. Authorization to execute the necessary documents to procure software and related services under the same terms and conditions as MA-758-1800000017, a Contract between SHI, Inc. and the Commonwealth of Kentucky, including proposal #24914828 (for a total cost of \$1,306,579.09; funds are Budgeted), attached hereto and incorporated herein by reference, and any future proposals related to annual renewal of this Microsoft Enterprise Agreement, determined to be necessary, cost effective and feasible by the Chief Information Officer and the Division of Procurement. Section 2 - That the Chief Information Officer, or her designee, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute any necessary documents related to the procurement. Section 3 - That an amount, estimated not to exceed the sum of \$1,306,579.09 in FY 2025, is hereby authorized for payment to SHI, Inc., from account #1101-202505-76102 (\$1,110,592.23), account #1115-202505-76102 (\$91,460.54), account #4002-202505-76102 (\$65,328.95), and account # 4051-202505-76102 (\$39,197.37) pursuant to the terms of the Agreement, with renewal contingent upon the Budgeting of sufficient funds in future fiscal years.
