## **URBAN COUNTY GOVERNMENT:**

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended for various appropriations as approved during Committee of the Whole fund balance meeting and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$\_55,901,205.00\_ \_from\_ the Unappropriated Fund Balance in the General Services District-General Fund to various accounts.

) Re-appropriations within the General Fund Capital Projects Fund, Affordable Housing and Homelessness Fund, and the Lexington Economic Development Fund which does not result in changes to the Unappropriated Fund Balance of this fund.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0025", attached hereto and incorporated herein by reference.
