A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute an Addendum to the Agreement with Wiser Strategies, for media planning and placement services for the Div. of Environmental Services, expanding the scope of the Agreement to provide for additional services for public outreach related to the Metropolitan Planning Organization (MPO) and the Safe Streets campaign, and increasing the Contract price by the sum of \$50,000, from \$225,000 to \$275,000. Authorization to execute the Second Amendment to the Agreement for Contract #234-2019 with Wiser Strategies, increasing the Contract amount by a not-to-exceed \$50,000.00 annually, and broadening the scope of work to support the Metropolitan Planning Organization and the Safe Streets campaign.
