An Ordinance amending certain of the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$2,300 for the Div. of Streets and Roads to fund the installation of an ADA sidewalk ramp on Mitchell Ave., Schedule No. 52. WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$2,300.00 for the Division of Streets and Roads from Neighborhood Development Funds for the installation of an ADA sidewalk ramp on Mitchell Avenue:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$2,300.00 for the Division of Streets and Roads from Neighborhood Development Funds for the installation of an ADA sidewalk ramp on Mitchell Avenue and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated are detailed in Schedule No. 0052 attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
