An Ordinance amending the Classified Civil Service authorized strength by abolishing one (1) position of Administrative Specialist, Grade 513N, and one (1) position of Social Worker Sr., Grade 516E, and creating one (1) position of Administrative Specialist Sr., Grade 516N, and one (1) position of Case Management Coordinator, Grade 520E; reclassifying incumbents in the Div. of Adult and Tenant Services, effective upon passage of Council. [Div. of Human Resources, Maxwell]  
Authorization to abolish one (1) classified position of Administrative Specialist (Grade 513N) and one (1) classified position of Social Worker Sr. (Grade 516E) and create one (1) classified position of Administrative Specialist Sr. (Grade 516N) and one (1) classified Case Management Coordinator (Grade 520E); reclassifying the incumbents within the Division of Adult and Tenant Services, effective the beginning of next pay period following passage of Council. This has a 12-month future impact of a cost of \$15,519.17 and funds are Budgeted. (L0907-16) (Maxwell/Hamilton)

strength be and hereby is deleted.

Section 2 - That the following subsection line number in the Classified Civil Service authorized strength be and hereby is created to read as follows:

Section 3 - That the following subsection line numbers in the Classified Civil Service authorized strength be and hereby are amended to read as follows:

620.045      2      110    516N      Administrative Specialist Sr.

620.040      1      515    516E      Social Worker Sr.

Section 4 - That the incumbent, Chelanda Holliday, be and hereby is reclassified from Administrative Specialist, Grade 513N, at \$19.606 hourly to Administrative Specialist Sr., Grade 516N, at \$21.959 hourly.

Section 5 - That the incumbent, Sharon Smith, be and hereby is reclassified from Social Worker Sr., Grade 516E, at \$2,093.92 biweekly to Case Management Coordinator, Grade 520E, at \$2,387.04 biweekly.

Section 6 - That this Ordinance shall become effective on passage of Council.
