An Ordinance amending Section 2-496 of the Code of Ordinances to increase the membership of the Mayor's International Affairs Advisory Commission to twenty-eight (28) members by increasing the number of members from Africa; Asia; Europe; the Americas; and the Middle East, from ten (10) to fifteen (15) collectively. [Mayor's Office, Scott]

Authorization to amend Article XLVII of Chapter 2 of the Code of Ordinances, related to the Mayor's International Affairs Advisory Commission, to increase the membership of the ten foreign-born residents to fifteen, by adding one additional member to each of the five specified geographic regions. BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Section 2-496 of the Code of Ordinances be and hereby is amended to read as follows:

Sec. 2-496. - Membership.

The commission shall consist of twenty-eight (28)members, twenty-two confirmation by (22)which shall be appointed by the Mayor, subject to of shall majority the council. The twenty-two appointed members (22)consist of two (2) members from the Lexington-Fayette Urban County Council: Fifteen (15)members shall be selected from Lexington-Fayette County foreign-born residents who shall be from represent following international geographic areas: three (3) representatives from Africa: three (3) representatives from Asia; three (3) representatives from representatives Europe: three (3) from the Americas; and three (3) representatives from the Middle East. Five (5) members shall be from the organizations community-at-large, academia which from or other specialize specific interests in or have or competencies in global business, immigration, refugees, international affairs. Six members shall or (6) following officers: the chief administrative the urban county government commissioner social services designee. officer or designee, the of or commissioner of general services or designee, the commissioner of public chief officer safety or designee, the development or designee and the Coordinator. Multicultural **Affairs** The six (6) members from the urban county government shall be non-voting ex-officio members.
