An Ordinance amending certain of the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$54,000 in the Div. of Parks and Recreation from the Council Capital Funds for benches and new trail signage along the Brighton/Liberty Trail, and appropriating and re-appropriating funds, Schedule No. 42. WHERAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government

to reflect current requirements for funds in the amount of \$54,000 in the Division of Parks and Recreation from the

Council Capital Funds for benches and new trail signage along the Brighton/Liberty Trail:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY

GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are

amended to reflect current requirements for funds in the amount of \$54,000 in the Division of Parks and Recreation from

the Council Capital Funds for benches and new trail signage along the Brighton/Liberty Trail and that to effect such

Amendments the following appropriations be and hereby are authorized and directed:

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated are detailed in Schedule No. 0042 attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
