) \$\_144,966.37\_ \_from\_ the Unappropriated Fund Balance in PFC - Parks Project Fund \_to\_ various accounts.

) \$\_6,512.00 \_ from\_ the Unappropriated Fund Balance in Enhanced 911 Fund \_to\_ various accounts.
