[Div. of Water Quality, Martin]

Authorization to approve Change Order #1-Final, in the amount of \$19,880.00 to Judy Construction Company for services provided to Town Branch WWTP Headworks Improvements project. The increase in the Contract amount includes the addition of a corrosion proof coating to a roof top HVAC unit, control panel modifications and relocation to a non-hazardous area and a credit for exchanging valves. The revised Contract amount including this Change Order will be \$987,880.00, a 2.05% increase in the original Contract amount. Funds are Budgeted. (L0329-17) (Martin/Hoskins-Squier)
