Authorization to abolish one (1) vacant classified position of Electrical Instrumentation Technician (Grade 516N), one (1) vacant classified position of Landfill Inspector (Grade 509N) and one (1) vacant position of Operations Manager (Grade 520E) create three (3) classified positions of Administrative Specialist (Grade 513N), one (1) classified position of Public Service Worker (Grade 507N) and one (1) position of Staff Assistant Sr. (Grade 510N) in the Division of Waste Management, effective upon passage by Council.
