BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Resolution No. 383-2016 be and hereby is amended to authorize and direct the Mayor, on behalf of the Urban County Government, to execute the Amended MOU, which is attached hereto and incorporated herein by reference, with the Commonwealth of Kentucky Finance and Administration Cabinet and the Kentucky Communications Network Authority, for the purchase and installation of additional dark fiber-optic cable for the Urban County Government and the Grant of a license to use vacant government-owned conduit in exchange for a credit in the amount of \$70,320.00.

Section 2 - That an amount, not to exceed the sum of \$270,000.00, be and hereby is approved for payment to the Commonwealth of Kentucky Finance and Administration Cabinet and the Kentucky Communications Network Authority, from the following accounts: account #1101-210101-76101 (\$20,000.00), #1101-210101-71299 (\$53,462.00), and 1101-202505-76102
