System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban

County Government's enhanced 911 Emergency Telephone Communication System (the "911

System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that

street names and property addresses conform to the standards established in Section 17-2 through

17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts

do not meet the Code requirements and changes should be made to conform to the Code and to

accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE
