WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

Government to provide funds for additional purchase orders and pre-paid expenses rolling from FY 2019 into FY 2020:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are

amended to provide funds for additional purchase orders and pre-paid expenses rolling from FY 2019 into FY 2020, and

that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$_97,531.14 _from_ the Unappropriated Fund Balance in the General Services District-General Fund _to_ various accounts.

) \$_4,000.00_ _from_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund _to_ various accounts.

) \$_1,000.00_ _from_ the Unappropriated Fund Balance in the Landfill Fund _to_ various accounts.

) \$_1,744.00_ _from_ the Unappropriated Fund Balance in the Enhanced 911 Fund _to_ various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0005", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.

WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to provide funds for additional purchase orders and pre-paid expenses rolling from FY 2019 into FY 2020.

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to provide funds for additional purchase orders and pre-paid expenses rolling from FY 2019 into FY 2020, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$97,531.14 from the Unappropriated Fund Balance in the General Services District-General Fund to various accounts.

) \$4,000.00 from the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund to various accounts.

) \$1,000.00 from the Unappropriated Fund Balance in the Landfill Fund to various accounts.

) \$1,744.00 from the Unappropriated Fund Balance in the Enhanced 911 Fund to various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0005" attached hereto and

incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
