WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to amend Budget related to purchase orders expensed to FY 2020:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to amend Budget related to purchase orders expensed to FY 2020, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$\_11,260.00\_ \_from\_ the Unappropriated Fund Balance in the General Services District Fund \_to\_ various accounts.

) \$\_234,132.25\_ \_to\_ the Unappropriated Fund Balance in the Full Urban Services District Fund \_from\_ various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0014", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.

) \$11,260.00 from the Unappropriated Fund Balance in the General Services District Fund to various accounts.

) \$234,132.25 to the Unappropriated Fund Balance in the Full Urban Services District Fund from various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0014", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
