BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute an Agreement, which is attached hereto and incorporated herein by reference, with the Kentucky Justice and Public Safety Cabinet, to accept a Grant in the amount of \$52,156.00 Federal funds under the Victim Assistance Formula Grant funded by the Victims of Crime Act ("VOCA"), for the support of a bilingual victim's advocate in the Division of Police in FY 2021, the acceptance of which will include the Urban County Government making an expenditure of \$13,539.00 as a planned local match.

Section 2 - That subject to the provisions of Ordinance No. 22-79, the Mayor is hereby authorized, in her discretion as Chief Executive Officer of the Urban County Government, to transfer the unencumbered balance of any operating or capital account appropriation to another operating or capital account appropriation within the Grant Budget previously established for this Grant.

Section 3 -- That this Resolution shall become effective on the date of its passage.
