WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$17,290.00 to provide funds for Council Projects in the Division of Traffic Engineering to cover costs associated with the installation of traffic calming/safety devices in the 11th District:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$17,290.00 to provide funds for Council Projects in the Division of Traffic Engineering to cover costs associated with the installation of traffic calming/safety devices in the 11th District and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
