BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 2 - That an amount, estimated not to exceed the sum of \$80,673.12, be and hereby is approved for payment to Evoqua Water Technologies, LLC, from the following accounts in the following amounts: #4002 - 303402 - 91017 (\$24,354.50) and #4002 - 303403 - 91017 (\$56,318.62), pursuant to the terms of the purchase requisition.
