NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

**URBAN COUNTY GOVERNMENT:** 

Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government

be amended to show a change in zone for property located at 4235 Harrodsburg Road (a portion of)

from an Agricultural-Urban (A-U) zone to a Neighborhood Business (B-1) zone, for 0.241 net (0.759

gross) acre, and for an Agricultural Urban (A-U) zone to a Townhouse Residential (R-1T) zone for

0.002 net (0.019 gross) acre, being more fully described in Exhibit "A" which is attached hereto and

incorporated herein by reference.

Section 2 - That the Lexington-Fayette Urban County Planning Commission is directed to

show the amendment on the official zone map atlas and to make reference to the number of this

Ordinance.

Section 3 - That this Ordinance shall become effective on the date of its passage.
