BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Section 5-29(20) of the Code of Ordinances of the Lexington Fayette Urban County Government be and hereby is created to read as follows:

For the review of Fire detection systems, the director, Div. of Building Inspection, shall receive a fee as follows: For systems up to 20,000 square feet \$275.00; over 20,000 square feet \$275.00 plus \$30.00 for each additional 10,000 square feet.

Section 2 - That Section 5-29(21) of the Code of Ordinances of the Lexington-Fayette Urban County Government be and hereby is created to read as follows:

For the review of Fire suppression systems, the director, Div. of Building Inspection, shall receive a fee according to the following schedule:

Sprinkler Systems

<u>4 - 25</u>	<u>\$150.00</u>
<u>26 - 100</u>	<u>\$200.00</u>
<u>101 - 200</u>	<u>\$250.00</u>
<u>201 - 300</u>	<u>\$275.00</u>
<u>301 - 400</u>	<u>\$325.00</u>
<u>401 - 750</u>	<u>\$375.00</u>
<u>Over 750</u>	<u>\$375.00 plus 30 cents per sprinkler.</u>

All other suppression systems \$275.00

Section 3 - That this Ordinance shall become effective upon the date of its passage.
