WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$2,500.00 for the Division of Environmental Services (Greenspace Commission) from Neighborhood Development Funds to assist with the final phase of Dantzler Court:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$2,500.00 for the Division of Environmental Services (Greenspace Commission) from Neighborhood Development Funds to assist with the final phase of Dantzler Court and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
