) \$\_56,314.49\_ \_from\_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund \_to\_ various accounts.

) \$\_225.00\_ \_from\_ the Unappropriated Fund Balance in the Water Quality Management Fund \_to\_ various accounts.

) \$\_2,230.27\_ \_from\_ the Unappropriated Fund Balance in the Enhanced 911 Fund \_to\_ various accounts.

) \$\_60,611.48\_ \_from\_ the Unappropriated Fund Balance in the Health Insurance Fund \_to\_ various accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0004", attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.

) \$225.00 from the Unappropriated Fund Balance in the Water Quality Management Fund to

various accounts.

) \$2,230.27 from the Unappropriated Fund Balance in the Enhanced 911 Fund to various

accounts.

) \$60,611.48 from the Unappropriated Fund Balance in the Health Insurance Fund to various

accounts.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which

funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0004", attached hereto and

incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
