WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to amend Budget related to purchase orders expensed to FY 2021:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to amend Budget related to purchase orders expensed to FY 2021, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
