BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Urban County Government hereby ratifies the Mayor's prior execution of an agreement with the Kentucky Transportation Cabinet, Office of Highway Safety, to accept a grant in the amount of \$20,000.00 in Federal funds for Impaired Driving services, the acceptance of which does not obligate the Lexington-Fayette Urban County Government for the expenditure of funds.
