NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 4 - That the provisions contained herein are in addition to all other means of amending any Grant Budget, and are not a limitation on such means.
