WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the property street name of the following property be and hereby is changed as follows:

(a) Bryan Station Road

<u>Current</u> 1686 Bryan Station Road

Section 2 - That the street name and property address number of the following property be

and hereby is changed as follows:

(a) <u>Versailles Road</u>: That the name of Versailles Road located at 1812 is changed to Hill Rise Drive and the following number change is made:

<u>Current</u> 1812 Versailles Road

<u>New</u> 1824 Hill Rise Drive

(b) <u>Winchester Road</u>: That the name of Winchester Road located at 999 is changed to Hillcrest Avenue and the following number change is made:
<u>Current</u>
<u>999</u> Winchester Road
<u>New</u>
103 Hillcrest Avenue

Section 3 - That Resolution 324-2021 Item (c) is amended to change 560

Waveland Museum Lane to 550 Waveland Museum Lane.

Section 4 - That this Resolution shall be effective thirty (30) days from passage.
