WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to

reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and

#### hereby are authorized and directed:

) \$\_2,185.80 \_\_from \_\_Donation Fund \_to \_ various accounts.

) \$\_220,300.00\_\_from\_\_Municipal Aid Program Fund \_to\_ various accounts.

) \$\_2,273.98\_to\_2023 Bond Projects Fund from various accounts.

) \$\_65,000.00\_to\_Extended School Program Fund from various accounts.

) Re-appropriations within the General Services District Fund; General Fund Capital Projects; Sanitary Sewer Construction

Fund; Water Quality Construction Fund; and Grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0006" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage. WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban

County Government to reflect current requirements for municipal expenditures.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$2,185.80 from Donation Fund to various accounts.

) \$220,300.00 from Municipal Aid Program Fund to various accounts.

) \$2,273.98 to 2023 Bond Projects Fund from various accounts.

) \$65,000.00 to Extended School Program Fund from various accounts.

) Re-appropriations within the General Services District Fund; General Fund Capital Projects; Sanitary Sewer Construction Fund; Water Quality Construction Fund; and Grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0006" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
