BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

One (1), which is attached hereto and incorporated herein by reference, to the Agreement with Strand Associates, Inc., for investigation and design services for improvements to the West Hickman Waste Water Treatment Plant, a Remedial Measures Project required by the Consent Decree, increasing the Contract price by \$53,870.00, from \$179,000.00 to \$232,870.00.

Section 2 - That an additional amount, not to exceed the sum of \$53,870.00, is hereby authorized for payment to Strand Associates, Inc., from account # 4003-303401-3401-92711, pursuant to the terms of the Change Order.
